Legislative Update FEDERAL POLICY

- In December, the US EPA, under the previous administration, closed the public comment period for its <u>Draft National Recycling Strategy</u>.
- In mid-January, the incoming Biden administration nominated Indiana's Janet McCabe, who taught at the McKinney School of Law at IUPUI and led Indiana University's Environmental Resilience Institute, as the deputy administrator for the US EPA.
- The Biden administration, which <u>has already acted</u> on environmental justice and climate change policies, has not yet signaled a specific policy priority related to recycling. Read more in <u>Waste Dive</u>.
- The Recycling Partnership urges the EPA to take action now on recycling policy. <u>Read more</u>.



STATE POLICY

• Currently, the only legislation that has been introduced in the 2021 session of the Indiana General Assembly is <u>HB 1325</u>, authored by Representative Gutwein, who chairs the House Environmental Affairs Committee. The bill urges the legislative council to assign to the appropriate interim study committee the task of studying the recycling operations of solid waste management districts and how to promote the economic viability of those recycling operations. It has been referred to the Committee on Rules and Legislative Procedures.
