We hit the ground running in 2020, and I'm happy to share some things we're working on in the hopes you'll **share your feedback and thoughts with us!** My goal is that these newsletters serve as an opportunity for our members to engage with us in a conversation - not just a one-way "update" on what we are doing.

IRC Site Visits:

One of the most important things we can do to better serve our members is to visit them, ask questions, and listen to their needs and concerns. Site visits are our best way to do this: we go meet with them in their element and see their operations. If you've not yet had a visit from the IRC, **reach out and let's get**

something on the calendar. Help us think about who else we can visit when we're in your neck of the woods, too. It's not a prerequisite, but if we leave with muddy boots, that's a bonus!

Conference 2020 Planning:

We're thinking strategically about how our Conference can facilitate a conversation this year and in future years as it relates to our strategic priority of capturing the statewide impact of significant improvements to recycling in Indianapolis. With this in mind, we have developed a theme: Integrated Waste Management: The Circular Economy and the Complexities of Wastes.

We're also working on a Glass Recycling Summit - with the intention that this is not a one-and-done or a one-way conversation. Our desire to address the challenges and opportunities of this commodity as part of our larger strategy to 'fix recycling in Indianapolis' is what drives us, and this article in **Resource Recycling Magazine** inspired us.

New IRC Event - Full Circle:

As we look to the future of IRC and our role in the state, we're working on programs that allow us to be a proactive advocate for our members at the state and local level.

To that end, we are planning our first regional event to convene Indiana's leaders in the circular economy. The event is titled Full Circle and will be held at least once annually in different regional locations across Indiana. The half-day event will bring together IRC members and partners within the region for an intentional discussion about the current activity in the recycling and circular economy industry in the region and the economic development opportunities that exist. The program will consist of a tour at an IRC member organization, a moderated panel discussion, followed by a networking event and possibly a press event.

The purpose of this event is to elevate the challenges and opportunities as it relates to economic development and policies within the region and to **facilitate** *member-to-member* and *member-to-elected official* **relationship-building**. We intend to host the first one in the Lafayette area this fall and showcase the results of our WHIN-region infrastructure investments study.

Does anything above interest you? Excite you? Give you pause? Let me know! Text me, call me or email me - I'm all ears! Where should we go next? What are our blind spots? How can you help, or how does your organization want to be involved?



NEW BOARD MEMBER Spotlight

Michelle Smith is the Executive Director of the Knox County Recycling and Solid Waste Management District. As Executive Director, she wears many hats. She is responsible for implementing and overseeing the entire solid waste management program in Knox County in compliance with applicable Indiana and federal laws. She establishes an operating budget and oversees financial constraints and expenditures. She is responsible for the implementation of the District's 20-year plan and regulations as well as the District's recycling and Household Hazardous Waste collection programs. With a teaching background, education is second nature to Michelle. She serves as the District's Educator and is also responsible for developing, implementing, and maintaining environmental education and outreach programs for students and residents throughout the county.

Michelle coordinates with the SWMD Board of Directors, the SWMD Citizens Advisory Committee, and other local, county, and state officials. The District works with private businesses to provide solid waste and



hazardous materials handling and recycling services within Knox County. Michelle also serves on the Association of Indiana Solid Waste Management Districts (AISWMD) Board and is an member of the Solid Waste Association of North America (SWANA): Indiana Chapter, the Indiana Household Hazardous Waste Task Force, and the North American Hazardous Materials Management Association.

Michelle's was first introduced to the IRC when she attended the 2014 annual conference as the District Educator. Since then she has attended the event annually as well as IRC's REVENT Gala. Through her involvement with the IRC, she recognizes that partnerships between the IRC and local municipalities can do incredible things. Michelle is a supporter of the IRC because of their commitment to collaborate with local municipalities and Solid Waste Districts to educate Hoosiers statewide about the importance of recycling and living sustainably for a better future.

PARTNERSHIP Updates



The Recycling Partnership recently published a comprehensive report that analyzes the changing landscape of curbside recycling in the US. The report, titled 2020 State of Curbside Recycling Report, details the drop in value of curbside commodities, dispels the panicked myth that 'recycling is dead,' and describes the pressure placed on local municipalities as materials processing facility (MRF) costs have increased. We appreciate this quote, from <u>Keefe Harrison</u>, CEO of The Recycling Partnership, who sees the opportunity in this moment:

"It is clear that unless stakeholders from across the value chain align and step up, we will not be able to drive the change necessary to move recycling in the U.S. to the next level. Every day we hear from citizens, communities, policy makers, corporate leaders, and other NGOs who all want the same thing - a stronger recycling system. It will take bold public-private partnership and leadership to make lasting improvements. Now is the time for action."
